CERTIFICATION OF ACCEPTANCES TO CHAPTER 11 PLAN
PURSUANT TO LOCAL BANKRUPTCY RULE 3018-1

This certification is submitted in accordance with Local Bankruptcy Rule 3018-1 in the Southern District of New York.

1. On April 28, 2011 (the "Filing Date"), The Christian Brothers' Institute, Inc. and The Christian Brothers' of Ireland, Inc. (the "Debtors") filed voluntary Chapter 11 petitions with the Clerk of this Court.

2. Pursuant to §1107 and §1108 of the Bankruptcy Code, the Debtors have continued in the operation of their businesses and remained in control of their assets during the pendency of their Chapter 11 case.

3. On December 10, 2013, this Court signed an order approving the Debtor's First Amended Disclosure Statement and authorized the Debtor to solicit acceptances or rejections to the Plan of Reorganization dated August 22, 2013 (the "Plan").

4. The Plan consists of ten (10) classified classes of claims and interests.

5. Class 1 consists of holders of Other Priority Claims. Class 1 is not impaired as that term is defined in §1124 of the Bankruptcy Code and not entitled to vote for or against the Plan.

6. Class 2 consists of holders of Secured Claims. Class 2 is not impaired as that term is defined in §1124 of the Bankruptcy Code and not entitled to vote for or against the Plan.

7. Class 3 consists of holders of General Unsecured Convenience Claims. Class 3 is not impaired as that term is defined in §1124 of the Bankruptcy Code and not entitled to vote for or against the Plan.

8. Class 4 consists of Sexual Abuse Claimants. Class 4 is impaired as that term is defined in §1124 of the Bankruptcy Code. A total of three hundred and sixteen (316) Class 4 ballots, with claims totaling \$315.00, were received, three hundred and fifteen (315) of which voted in favor of the Plan. As such, Class 4 has voted to accept the Plan.

9. Class 5 consists of holders of Fraud Claims. Class 5 is impaired as that term is defined in §1124 of the Bankruptcy Code. A total of zero (0) Class 5 ballots, with claims totaling \$0.00, were received. As such, Class 5 did not vote in favor or against the Plan.

10. Class 6 consists of holders of Physical Abuse Claims. Class 6 is impaired as that term is defined in §1124 of the Bankruptcy Code. A total of zero (0) Class 6 ballots, with claims totaling \$0.00, were received. As such, Class 6 did not vote in favor or against the Plan.

11. Class 7 consists of holders of Maintenance Claims. Class 7 is not impaired as that term is defined in §1124 of the Bankruptcy Code and not entitled to vote for or against the Plan.

12. Class 8 consists of holders of General Unsecured Claims. Class 8 is impaired as that term is defined in §1124 of the Bankruptcy Code. A total of ten (10) Class 8 ballots, with claims totaling \$5,443,329.03, were received, all of which voted in favor of the Plan. As such, Class 8 has voted to accept the Plan.

13. Class 9 consists of Penalty Claims. Allowed Penalty Claims, if any, will be subordinated to all other Allowed Claims and will receive no distribution under the plan. Accordingly, pursuant to §1126(g) of the Bankruptcy Code, Class 9 is deemed to reject the Plan.

14. Class 10 consists of Abuse Related Contingent Contribution/Reimbursement /Indemnity Claims. In accordance with section 502(e) (1) of the Bankruptcy Code, each Abuse Related Contingent Contribution/Reimbursement /Indemnity Claim held by any Person or Entity against the Debtors shall be disallowed, will receive no distribution under the Plan, and pursuant to §1126(g) of the Bankruptcy Code, is deemed to reject the Plan.

15. Original ballots are in possession of the Balloting Agent.

16. Based upon the above, the Plan has been accepted by at least one class of impaired claims, excluding insiders. Specifically, Classes 4 and 8 voted in favor of the Plan. However, since certain classes as set forth above either did not vote or are deemed to reject the Plan, the Debtors will request that the Court will confirm the Plan under §1129 (b) of the Bankruptcy Code.

17. The pertinent information from the Ballots received from holders of Claims in Class 4 and Class 8 (the "Counted Ballots") were recorded on the ballot tabulation reports (the "Ballot Tally Sheets") attached hereto as Exhibit A and Exhibit B respectively.


